The South Dakota AFL-CIO Jack Dudley Memorial Scholarship Award

ELIGIBILITY

Applicants must be a member in good standing of a union affiliated with South Dakota State Federation of Labor, AFL-CIO, or a spouse, child, grandchild or stepchild of a union member in good standing of a union affiliated with the South Dakota State Federation of Labor, AFL-CIO.

The union member must be a member in good standing for at least six (6) months prior to application for the scholarship. A member who has been newly hired within this six (6) month period shall also be eligible if he/she is a member in good standing.

The applicant must be a high school senior, or have been accepted to or attending an accredited institution.

Previous winners are ineligible.

ELIGIBLE SCHOOLS

The scholarship may be used at any college, university, or vocational school.

AWARD

The winner will receive a \$500.00 scholarship for the following school year.

The winner will receive a scholarship certificate and the funds will be sent directly to the school that he/she will be attending.

The scholarship may be deferred for one (1) year in the case of illness or military service.

FUNDING

All funds shall come from the scholarship account, which is funded from the general fund of the South Dakota State Federation of Labor, AFL-CIO.

APPLICATION PROCEDURES

The applicant may request an application for the scholarship from the State Federation office or their local affiliate. The State Federation office address is:

The application form should be sent to the State Federation office and postmarked no later than Wednesday Feb. 1, 2023

The South Dakota State Federation of Labor reserves the right at any time and without giving any reason, to terminate, cancel, or end the scholarship program provide that scholarships or awards already granted and/or announced shall run to the end of the promised and publicly stated date.

SCHOLARSHIP COMMITTEE

The scholarship committee shall consist of the South Dakota State Federation of Labor Executive Council.

The scholarship committee will select one winner and one alternate by a lottery drawing at the legislative conference. All decisions of the scholarship committee are final.
